

#### UDHAGAMANDALAM RACES 2024 12TH DAY, SUNDAY 12TH MAY 2024 RACING INCIDENTS (71-77)

TRACK CONDITION: GOOD GOING PENETROMETER READING : 3.50 CMS RAILINGS POSITION:NO FALSE RAILS

### <u>1st Race: 71. The Royal Calcutta Turf Club Trophy - (About) 1200 metres. Horses</u> rated 20 to 45 (8 Runners).

MARQUITA (Koshi Kumar) got stuck inside the gate resulting in contusion of Right stifle and was withdrawn before coming under the starter's order.

At the start Jockey M.S.Deora, (GAJABO GRANDE DRAWN 8) jumped outwards and went across sharply on to.ARJUN (P.Sai Kumar drawn -6).

Jockey M.S.Deora, the rider of GAJABO GRANDE was fined Rs 5,000/- for not exercising proper control at the start.

Jockey Surya Prakash, rider of PRESTO POWER was fined Rs 5,000/- for not exercising proper control in the straight, shifted out under the use of his whip thereby tightening GAJABO GRANDE (M.S.Deora) who in turn went on to ARJUN (P.Sai Kumar)on his inside.

Routine Sample was taken for analysis from the winner PRINCE PURPLE (C Umesh).

#### <u>2<sup>nd</sup> Race: 72. The Turf Authorities Of India Trophy - (About) 1800 metres. Horses</u> rated 20 to 45 (6 Runners).

Jockey P.Sai Kumar, the rider of ABILITARE reported his horse was hanging in throughout the race. The Club's Veterinary Officer was asked to examine the mare who reported after the race that no abnormalities were found.

Jockey Sah Farid Ansari rider of ABNEGATOR reported that his whip got entangled in the last 50 metres while he was changing his whip hand.

Routine Sample was taken for analysis from the winner WOLF CREEK (Soufyane J Moulin).

### <u>3rd Race: 73. The Dr.M.A.M.Ramaswamy Memorial Stakes - (About) 1400 metres.</u> For Indian Horses, 4 Year old & Over (8 Runners).

AMAZONIA (Yash Narredu) was slowly away.

Jockey P.Sai Kumar, the rider of ANZIO reported that around 600 metres bend GOLDEN MARINA (Surya Prakash) shifted on to him.STILL I RISE (C Umesh) who was on his haunches had to check momentarily.

Jockey Hindu Singh, the rider of DEDICATE reported loss of whip at the 200 metres

The Club's Veterinary Officer was asked to examine STILL I RISE (C Umesh) who reported after the race, that he had pulled up lame on Right fore during the race. Trainer Fahad Khan was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Routine Sample was taken for analysis from the winner DEDICATE (Hindu Singh).

#### <u>4th Race: 74. The Sardar K.B.Ramachandra Raj Urs Memorial Trophy - Div. I -</u> (About) 1200 metres. Horses rated 60 to 85, 4 years old and over (10 Runners).

The saddle on SECRET PEARL(P.Vikram) shifted in.Trainer Vijay Singh was fined Rs 2000/- for faulty saddling of his charge SECRET PEARL (P.Vikram).

Routine Sample was taken for analysis from the winner KNIGHT IN HOOVES (Kuldeep Singh).

### <u>5th Race: 75. The HPSL Nilgiris Derby Stakes (Grade I) - (About) 1600 metres. For</u> <u>3 year old Indian Horses only (Foaled in 2021) (11 Runners).</u>

The Saddle on VINALIA(L.Alex Rozario) shifted in.Trainer Vijay Singh was fined Rs 2000/-for faulty saddling of his charge VINALIA (L.Alex Rozario).

Around the bend BHARAT (C Umesh) shifted in and went across KING'S BATTALION (Ashhad Asbar) who in turn went on to STORM SHADOW (Vivek G) who was on the rails. Jockey Vivek G, the rider of STORM SHADOW had to check his mount momentarily.Jockey C Umesh, the rider of BHARAT was cautioned.

An Objection was lodged byJockey Yash Narredu, the rider of THIS IS GOLD placed 2nd by the Judge against JockeyP.Sai Kumar, the rider of ROYAL DEFENDER placed

1st by the Judge for " coming around the bend passing the 900 meters the winner was two horses wide.approaching the 800 metres.He has come in very sharply which made me stop riding and pull out of his heels(the winner) which cost me atleast 5 to 6 lengths from there my filly has caught upto him if the interference was not caused I would have certainly won this race".The Stewards interviewed both the Jockeys and after viewing the CCTV replay of the race decided to overule the objection with no change in the order of placings as declared by the Judge.

Jockey Yash Narredu, the rider of THIS IS GOLD was severely cautioned for shifting out forcing and carrying KING'S BATTALION (Ashhad Asbar)and GO FOR THE MOON (Hindu Singh)around the bend.

Routine Sample was taken for analysis from ROYAL DEFENDER (P.Sai Kumar) the winner, THIS IS GOLD (Yash Narredu) placed II, and GREY WIND (Akshay Kumar) placed III.

#### <u>6<sup>th</sup> Race: 76. The Royal Western India Turf Club Ltd Trophy - (About) 1500</u> metres. Horses rated 40 to 65 (10 Runners).

Permission was granted to Trainer Deepesh Narredu to declare Jockey C A Brisson, to ride BRILLIANT LADY in place of Jockey Yash Narredu who was indisposed.

Permision was granted to Trainer Ajith Kumar V to declare L.Alex Rozario, to ride GRANDIOSE in place of Jockey Ashhad Asbar who was indisposed.

GANTON (P.Vikram) and ROYAL FALCON (Sah Farid Ansari ) missed the footing at the start while jumping out.

The Club's Veterinary Officer was asked to examine GRANDIOSE (L.Alex Rozario) and ROYAL FALCON (Sah Farid Ansari) he reported after the race that no abnormalities were found on both.

The Club's Veterinary reported after the race that no abnormalities were found in ROYAL BARON (Koshi Kumar).

Routine Sample was taken for analysis from the winner STARKOVA (Soufyane J Moulin).

#### <u>7<sup>th</sup> Race: 77. The Sardar K.B.Ramachandra Raj Urs Memorial Trophy - Div. II -</u> (About) 1200 metres. Horses rated 60 to 85, 4 years old and over (10 Runners).

Permission was granted to Trainer Ramanathan R to declare Jockey P.Vikram, to ride KNOTTY WONDER in place of Jockey Vivek .G who was indisposed.

GODS PLAN (Surya Prakash) was very fractious inside the stalls and was withdrawn before coming under the starter's orders.

Jockey R.S.Jodha, the rider of SOFT WHISPER was severely reprimanded for not exercising proper control on his mount taking OPUS ONE (C Umesh)outwards around the bend.

SONIC DASH (A S .Peter)advised two mock races.

Routine Sample was taken for analysis from the winner KNOTTY WONDER (P.Vikram).

Licenced Professionals: Trainer Vijay Singh and Jockey P. Vikram

A Stewards Enquiry was held into the riding of Jockey P Vikram on his mount "LAVISH GIRL" in race No.33 –The Smart Chieftan Plate, run on Sunday, 21st April 2024 at the Weighing room ,Madras Race Club ,Hobart Park, Udhagamandalam at 5,30 pm on Friday 10th May 2024.who was issued a charge sheet No-40,under Rule No159(b) and 161(ii)of the Madras Race Club Rules of Racing for unsatisfactory riding and riding an indifferent race.On being questioned by the Stewards, Jockey P Vikram stated that there was no specific instructions since he had ridden the filly three times, he mentioned she had a small dash and wanted to use to her advantage. When pointed out by the Stewards why he was not with the bunch when the start was effected, he did not have a plausible answer. The Jockey stated that he

was niggling her from 600 meters to keep up with the field and in the straight the winner (ROYAL DEFENDER )took off .

Trainer Vijay Singh was called in and asked to explain Jockey P Vikram's ride on his charge "**LAVISH GIRL**".He informed the Stewards that Jockey P.Vikram had ridden the filly three times and knew her well. He explained that the race came in early for her and maybe in his opinion the Jockey misjudged the race, he should have made his move much early thus placing his mount to a disadvantage position. He also opined that Jockey had no malafide intention.

In the presence of Jockey P Vikram and Trainer Vijay Singh, Race No. 33 was viewed. and was pointed out to the Jockey that he had all the opportunity to sit well up

In the presence of Jockey P Vikram and Trainer Vijay Singh, Race No. 33 was viewed. and was pointed out to the Jockey that he had all the opportunity to sit well up however, he decided to sit in the mid field thus placing his mount to a disadvantage and not keeping up with the field.

Having heard the submissions made by Jockey P Vikram and Trainer VIjay Singh and having viewed the race in question, the Stewards of the Club, along with the Chief Stipendiary Steward, after deliberation decided to suspend Jockey P Vikram's licence for 6 race days i.e. 25<sup>th</sup> and 26<sup>th</sup> May, 2<sup>nd</sup> June of Udhagamandalam Races and,1st,7th and 14<sup>th</sup> September 2024 of Madras Racing Season 2024-2025 for Unsatisfactory Riding and was severely warned to be more careful on his rides

He was permitted to ride work.

He was informed about his right to appeal.
