TRACK CONDITION: GOING SOFT PENETROMETER READING: 4.10 CMS RAILINGS POSITION: NO FALSE RAILS

<u>1st Race: 78. The Gold Coast Handicap - (About) 1300 metres. Horses rated 00 to 25 (10 Runners).</u>

LADY ZEEN (M.S.Deora) lost its Right fore shoe soon after the start.

Due to crowding from shifting in LADY ZEEN (M.S.Deora) at the 400 meters onto MIDNIGHT SPARKLE (P.Sai Kumar),YELLOW SAPPHIRE (A.M.Tograllu) had to be checked negotiating the turn. RUN HAPPY RUN (P Ajeeth Kumar) who was on the inside shifted in on to the rails due to which AURORA BOREALIS (Sah Farid Ansari)was travelling on the fence had to be checked and make a rerun.

Jockey A.M.Tograllu, the rider of YELLOW SAPPHIRE reported he had to check his mount due to MIDNIGHT SPARKLE (P.Sai Kumar)shifting in passing the 400 metres.

Jockey C Umesh, the rider of ATREIDES also reported that he had to check his mount at the 900 meters .

Routine Sample was taken for analysis from the winner SUNCHE DREAMS (P.Vikram).

Due to incessant rains and track not being conducive for racing, The Stewards of the Club decided to cancell the remaining races of the day ie 2nd ,3rd,4th,5th and 6th Races.

ADDITIONAL REPORT

ORDER OF THE BOARD OF APPEAL

The Board of Appeal at its meeting held on Tuesday,14th May 2024 considered the appeal dated 1st May 2024 filed by Jockey Mr. Nakhat Singh against the decision of the Stewards of the Club taken at the meeting held on Saturday, 27th April 2024 unanimously decided as under:-

- (a) To partially modify the punishment imposed on Jockey Mr. Nakhat Singh, to the following effect:-
- (i) The withdrawal of "B" Jockey's license granted to Jockey Mr. Nakhat Singh and declaration of Jockey Mr. Nakhat Singh as a disqualified person under the Rules of Racing of Madras Race Club,shall be from 16th May 2024 up to15th November 2024 (both days inclusive) for breach of Rule159(a), 159(b),and 161 (ii)of the Madras Race Club Rules of Racing for his ride on "MULTICROWN" in Race No.36 run on 21st April 2024.
- (ii) During the period from 16th May 2024 up to 15th November 2024(both days inclusive) Jockey Mr.Nakhat Singh shall be treated as a disqualified person and shall be subject to all disabilities under the MRC Rules of Racing for a disqualified person.
- (b) To forfeit the deposit of Rs.5,000/- paid by Jockey towards the appeal fee.
