RACING INCIDENTS
(129-136)

TRACK CONDITION: GOOD GOING
PENETROMETER READING: 3.80CMS
RAILINGS POSITION: NO FALSE RAILS.

1st Race: 129. The New Year Trophy - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (8 Runners).

During routine Veterinary Examination on 31/12/24 at 10.53 a.m BLUE SAPPHIRE (Dharshan Antony) was observed to have Left fore superficial Digital Flexor Tendonitis. Trainer Ajith Kumar V was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Permission was granted to Trainer J. Sebastian to declare Jockey M.S. Deora, to ride MEMORY LANE in place of Jockey A.S. Peter who was indisposed and could not fulfill his riding engagements for the day.

The Club's Veterinary Officer was asked to examine AIR MARSHALL (Kuldeep Singh) and WAR EMBLEM (Koshi Kumar) who reported after the race that no abnormalities were found in both.

RINELLO (Hindu Singh) burst its blood vessel (EIPH) during the race. Trainer B. Suresh was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Routine Sample was taken for analysis from the winner MEMORY LANE (M.S. Deora)

2nd Race: 130. The Sha Tin Handicap - Div. I - (About) 1000 metres. Horses rated 20 to 45(Whips not allowed) (10 Runners).

During routine Veterinary Examination on 01/01/25 at 9.44 am, MULTIWAVE (Shah Alam) was observed to be trotting lame on Left hind due to injury to the hoof. Trainer B. Suresh was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Permission was granted to Trainer Deepesh Narredu to declare Jockey M Baskar, to ride BOMBER JET in place of Jockey A.S Peter.

Jockey P.Sai Kumar, the rider of PRINCE PURPLE reported that he did not get a clear run in the early stages of the race.

The Club's Veterinary Officer was asked to examine ROYAL MAYFAIR (P Trevor) who reported after the race that no abnormalities were found

SUNNY ISLES (Kuldeep Singh) was euthanized as she collapsed during the race resulting in severe head injury and hypovolemic shock.

At the behest of the Stewards, an Enquiry was initiated into the running of SUNNY ISLES (Kuldeep Singh).following which the mare was declared a non-starter.

Routine Sample was taken for analysis from the winner AARINI (Hindu Singh).

3rd Race: 131. The Sans Craintes Stud Million - (About) 1100 metres. For Maiden Horses 3 Years Old Only (3 Runners).

MEADOW SPRINGS during stalling jumped from the front barriers got loose and was apprehended at the 2000 metres marker. As such Trainer James Mckeown was contacted and with his due consent the colt was withdrawn before coming under starter's order. Trainer James Mckeown was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Routine Sample was taken for analysis from the winner SIR WINSTON (Akshay Kumar).

4th Race: 132. The Charenzaccio Handicap - (About) 1400 metres. Horses rated 20 to 45, 6 years old and over (12 Runners).

Permission was granted to Trainer B.Suresh to declare Jockey Kuldeep Singh, to ride MASTERPIECE in place of Jockey A.S.Peter.

Routine Sample was taken for analysis from the winner ADMIRAL SHAW (Inayat).

5th Race: 133. The Governor's Trophy - (About) 1800 metres. Horses rated 40 to 65 (6 Runners).

Trainer Deepesh Narredu was questioned regarding the improved performance of his charge GOLDEN WARRIOR (Hindu Singh) winner of this race as compared to his previous run in Race no 66 run on 9/11/24 where he

mentioned that due to the rains and since going was soft, he did not perform well. The Trainer also added that since the going was good on 1st January, 2025, the gelding came out and won the race.

Routine Sample was taken for analysis from the winner GOLDEN WARRIOR (Hindu Singh).

6th Race: 134. The South India Oaks (Grade II) - (About) 2400 metres. for 4 year old Indian Fillies only (Foaled in 2021) (5 Runners).

Permission was granted to Trainer M.M.Uthaiiah to deputize and saddle on behalf of Trainer N.Ravinder Singh for SKYWARD (Gaurav Singh) at both trainers risk and responsibilities.

The Club's Veterinary Officer was asked to examine GREY WIND (Hindu Singh) who reported after the race that no abnormalities were found.

Compulsory samples were taken for analysis from MAGNETIC (P Trevor) the winner, MOTHER'S GRACE (L.Alex Rozario) placed II & AQUASTIC (Akshay Kumar) placed III .

7th Race: 135. The Natalama Handicap - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

Permission was granted to Trainer B.Suresh to declare Jockey M.S.Deora, to ride CROWN ANGEL in place of Jockey A.S.Peter.

The Club's Veterinary Officer was asked to examine ITS MY CHANCE (Shyam Kumar) and AMAZING LIGHT (Inayat) who reported after the race that no abnormalities were found in both.

Routine Sample was taken for analysis from the winner AMAZING JOY (P Trevor).

8th Race: 136. The Natalama Handicap - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

At the start, MAGICAL WAND (M.S.Deora) whipped around and took no practical part in the race..

During routine Veterinary examination in the morning on 02/01/25, MAGICAL WAND (M.S.Deora) was observed to be trotting lame on left hind due to sprained stifle. Trainer Suraj Prasad Shaw was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Permission was granted to Trainer B.Suresh to declare Jockey Sah Farid Ansari, to ride SAINTLY STAR in place of Jockey A.S.Peter.

Routine Sample was taken for analysis from the winner DRAMATIC (P Trevor).

Jockey Kuldeep Singh, the rider of MASTERPIECE carried an overweight of 1 kg.

RINELLO (Hindu Singh) Tardy start.

DESERT FORCE (K V Baskar) Lost about a length

2nd Race: 130. The Sha Tin Handicap - Div. I (About) 1000 Metres

ANGAVAI (Dharshan Antony) Fly jumped awkwardly

3rd Race: 131. The Sans Craintes Stud Million (About) 1100 Metres

MEADOW SPRINGS (C Umesh) got free during the loading process and ran the full course. Hence withdrawn.

4th Race: 132. The Charenzaccio Handicap (About) 1400 Metres

ROYAL FALCON (Koshi Kumar) and MASTERPIECE (Kuldeep Singh) Tardy start.

5th Race: 133. The Governor's Trophy (About) 1800 Metres

QUEEN ANULA (P.Sai Kumar) Jumped awkwardly.

6th Race: 134. The South India Oaks (About) 2400 Metres

GREY WIND (Hindu Singh) Jumped awkwardly.

7th Race: 135. The Natalama Handicap - Div. I (About) 1400 Metres

AMAZING LIGHT (Inayat) and KING'S GUARDIAN (Sah Farid Ansari) Jumped awkwardly.

IT'S MY CHANCE (Shyam Kumar) Jumped awkwardly. Advised one gate.

8th Race: 136. The Natalama Handicap - Div. II (About) 1400 Metres

DRAMATIC (P Trevor) Lost about a length.

ETERNAL PEARL (M Bhaskar) Jumped awkwardly.

MAGICAL WAND (M.S.Deora) Turned around immediately after the start. SSC revoked.

ADDITIONAL REPORT

CHARGE SHEET No 042 issued to Trainer G.S.Parmar dated 25/12/24 into the positive finding of prohibited substance "**COBALT**"(Class III).in the Urine Samples (A Sample) collected from horses under the charge of Trainer G.S.Parmar.

B.m.5 yr old **AUTHENTIC BELL** (Race no 49, Winner run on 25/10/24)

B.m.5yr old **KALYANI MUSLR** (Race no 61, Winner run on 26/10/24)

B.m.5yr old **AUTHENTIC BELL** (Race no 77, Winner run on 22/11/24)

The Stewards of the Club at their meeting held on 23/11/24 considered the lab report received (dated 22/11/24) from Quantilab, Mauritius pertaining to

b.m.5 yr old **AUTHENTIC BELL** Winner of Race no 49 and b.m.5yr old **KALYANI MUSLR Winner** of Race no 61) which showed presence of **COBALT (Class III)** a prohibited substance in both urine samples of the said horses. The Stewards of the Club gave the option to Trainer G.S.Parmar for sending the split sample(s) of both horses urine for confirmatory analysis, whereby Trainer G.S.Parmar agreed and opted to send the split sample(S) to **LCH, France** for testing at his expenses.

The Stewards Meeting that was held on 7/12/24 considered both (B sample confirmatory reports) received from **LCH, France** (dated 12/12/24) that of **b.m 5 yr old AUTHENTIC BELL** and that of **b.m.5yr old KALYANI MUSLR** (dated 11/11/24) confirming presence of **COBALT (Class III)** in both horses above the international threshold limit.

The Stewards of the Club decided to disqualify both horses ie, b.m.5yr old **AUTHENTIC BELL Winner of Race no 49** and b.m.5yr old **KALYANI MUSLR** Winner of race no 61 and revised the order of placing. Subsequent to that Chief Veterinary Officer report that in the post urine sample lab report taken from 5yr old b.m. AUTHENTIC BELL(Winner race no 77 run on 22/11/24 received from **Quantilab,Mauritius** dated 23/12/24 has presence of prohibited substance **COBALT(Class III)**.

The Stewards at their meeting held on 25/12/24 after the last race in the Weighing Room decided to disqualify 5 yr old b.m.**AUTHENTIC BELL** from Race no 77(Winner) and revised the order of placing.

The Stewards of the Club at their meeting held after the last race on Tuesday 31/12/24 on the charge sheet no 042 issued to Trainer G.S.Parmar dated 25/12/24 on committed breach of liable for action to be taken under rule no **202(i),202(xa),202(16)** of MRC rules of racing with medication rule under calendar notification **12(2),13(a)(c)(d)(f)(g)(ia),23(a)(b)** against Trainer G.S.Parmar.

The Stewards of the Club considered the submissions made by Trainer G.S.Parmar in the above meeting date in conjunction with the verbal reports by Chief Stipendiary Steward and Chief Veterinary Officer and deliberated the matter in length and decided that the explanation and evidence tendered by Trainer G.S.Parmar were not satisfactory, in exercise of the powers vested in them by Madras Race Club Rules of racing and decided

(a) Trainer G.S.Parmar has contravened the Medication Rules/Calendar Notifications laid down by the Madras Race Club under MRC rules of racing

under the heading “**MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL**” in that his charge b.m.5 yr old **AUTHENTIC BELL**(Winner, Race no 49 and Race no 77) has tested positive for the presence of prohibited substance **COBALT(Class III)** in the primary & split urine sample (A&B Samples) above the international threshold limit also **KALYANI MUSLR**(Winner Race no 61) was tested positive for the presence of prohibited substance **COBALT(Class III)** in a post race urine sample.

(b) Trainer G.S.Parmar contravened the Madras Race Club Medication Rule under calendar notification **12(2),13(a)) (c)(d)(f)(g)(ia),23(a)(b)**.Also 5th breach of Medication and Antidoping for usage of performance enhancers and prohibited substances.

C) Found guilty of repeatedly violating usage of prohibited substance. Trainer G.S.Parmar is found guilty of violating/contravening Madras Race Club rule no **202(i),202(xa),202(16)** .

The Stewards decided to withdraw Trainer G.S.Parmar License granted under MRC Rules of Racing with effect from Wednesday, 01/01/25 upto 31st March 2025. And further resolved that should he apply for Trainers License, the same will not be considered until 1st April 2026. And also fine him Rs 90,000/- for contravening the Medication Rules.

During the period of Suspension Trainer G.S.Parmar will not:

(I) Be permitted to own or train horses.

II) Be permitted to act as an authorized agent under MRC Rules of Racing.
