RACING INCIDENTS
(25-32)

TRACK CONDITION: GOOD GOING
PENETROMETER READING: 4.0 CMS
RAILING POSITION: RAILINGS PLACED AT AN AVERAGE WIDTH OF 2 METRES FROM 1800 METRES & WIDENING UPTO 8 METRES FROM 1200 METRES TILL THE WINNING POST FROM ITS ORIGINAL POSITION.

1st Race: 25. The Serjeant At Arms Handicap - (About) 1600 metres. Horses rated 00 to 25, 4 years old and over (8 Runners).

BHAIRAVA'S QUEEN (P.S.Kaviraj) threw its head and jumped awkwardly at the start. The Club's Veterinary Officer when asked to examine the mare reported after the race that she had sustained bruises on left hind fetlock. Jockey C A Brisson, the rider of WELCOME CHAKKARAM was severely cautioned for not making efforts to improve position from 1400 metres till entering the straight thereby allowing the field to gain considerable ground before riding out in the straight.

The Club's Veterinary Officer reported after the race that SWISS AGATTA (Dharshan Antony) had sustained bruises on Right hind fetlock during the race.

The Club's Veterinary Officer reported that CATALYST (Sah Farid Ansari) lost left hind shoe during the race.

Compulsory sample was taken for analysis from BHAIRAVA'S QUEEN (P.S.Kaviraj).

Routine Sample was taken for analysis from the winner SWISS AGATTA (Dharshan Antony).

2nd Race: 26. The Antonios Handicap - (About) 1800 metres. Horses rated 20 to 45 (8 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for SHOWMANSHIP (P.S.Kaviraj) and VULCANIC (Shrikant Kamble) at both trainer's risk and liability.

Permission was granted to Trainer R.Ramanathan to deputise on behalf of Trainer James Mckeown for CHEVAL BLANC (S.Antony Raj) and MARTINGALE (Ramandeep Singh) at both trainer's risk and liability.

ROYAL PEARL (Yash Narredu) burst its blood vessel (EIPH) during the race. Trainer B.Suresh was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with her.

CHEVAL BLANC (S.Antony Raj) burst its blood vessel (EIPH) during the race. Trainer R.Ramanathan who was deputising for Trainer James Mckeown was informed to get the colt charge certified fit by the Club's Veterinary Officer before next accepting with him.

The Club's Veterinary Officer reported after the race that MASTERPIECE (P.Sai Kumar) had sustained superficial injury on Right hind cannon.

Routine Sample was taken for analysis from the winner QUEEN OF FAME (L.Alex Rozario) .

3rd Race: 27. The Diego Riveira Handicap - Div. II - (About) 1200 metres. Horses rated 20 to 45, 3 years old only(Whips not allowed) (10 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for LAUDREE (M.S.Deora) and WINNING LEGACY (P.S.Kaviraj) at both trainer's risk and liability.

Permission was granted to Trainer R.Ramanathan to deputise on behalf of Trainer James Mckeown for BIENFAISANT (S.Antony Raj) at both trainer's risk and liability.

MAGICAL WAVE (Dharshan Antony) jumped awkwardly outwards at the start.

SACRE COUER (Neeraj Rawal) jumped awkwardly and veered in forcing in MSG FANTASY (Indrajeet Kumar) onto BIENFAISANT (S.Antony Raj) who was further forced in onto WINNING LEGACY (P.S.Kaviraj) .The incident being accidental no action was initiated.

The Club's Veterinary Officer reported after the race that BIENFAISANT (S.Antony Raj) had sustained superficial injury on left fore coronate and LAUDREE (M.S.Deora) had sustained superficial injury on Right hock.

Routine Sample was taken for analysis from the winner WINNING LEGACY (P.S.Kaviraj).

4th Race: 28. The Diego Riveira Handicap - Div. I - (About) 1200 metres. Horses rated 20 to 45, 3 years old only(Whips not allowed) (9 Runners).

STAR LAP (Shrikant Kamble) was permitted to be withdrawn on veterinary grounds as she was trotting lame on Left hind due to the injury of fetlock. Trainer G.S.Parmar who was deputising for Trainer Adhiraj Singh Jodha was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with her.

NIGHTJAR (Sah Farid Ansari) was permitted to be withdrawn on veterinary grounds as she was trotting lame on Right fore due to high suspensory desmitis. Trainer R.Foley was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with her.

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for ATTENBOROUGH (P.S.Kaviraj)at both trainer's risk and liability.

Permission was granted to Trainer R.Ramanathan to deputise on behalf of Trainer James Mckeown for ANATOLIA (S.Antony Raj) at both trainer's risk and liability.

Routine Sample was taken for analysis from the winner LEBUA (Neeraj Rawal).

5th Race: 29. The Supervite Handicap - (About) 1400 metres. Horses rated 60 to 85 (12 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for EUPHORIC (P.S.Kaviraj) at both trainer's risk and liability.

SPEED AIR (Yash Narredu) clipped the heels of AYUR SHAKTI (Dharshan Antony) and stumbled due to crowding the field closing in soon after the start

The Saddle of FUN STORM (Sah Farid Ansari) shifted to the front in the race whereby the Jockey could not do justice on his mount. Trainer N. Rupa was fined a sum of Rs 3000/- for improper saddling of her charge FUN STORM (Sah Farid Ansari).

The Club's Veterinary Officer reported after the race that EUPHORIC (P.S.Kaviraj) lost left fore shoe during the race.

Routine Sample was taken for analysis from the winner EUPHORIC (P.S.Kaviraj).

The Stipendiary Stewards reported Jockey Dharshan Antony, the rider of AYUR SHAKTI to the Stewards after the last race:

The Stewards after viewing the CCTV replay of the race multiple times, considering the statement of the Stipendiary Stewards and after having questioned Jockey Dharshan Antony the rider of AYUR SHAKTI came to a conclusion that the Jockey was in breach of Rule 161(ii) of the Madras Race Club Rules of Racing and resolved as follows:

To suspend Jockey Dharshan Antony with effect from 20th November 2022 to 10th December 2022 (both days inclusive) for breach of Rule 161(ii) of The Madras Race Club Rules of Racing for Unsatisfactory riding on his mount AYUR SHAKTI in Race no.29 run on 10th November 2022, wherein:

Despite his mount AYUR SHAKTI being full of running entering the straight, Jockey Dharshan Antony permitted EUPHORIC (P.S.Kaviraj) the eventual winner of the race to take a considerable lead and thereafter after passing the 300 metres began riding and in that he did not ride out to potential and rode a very feeble ride till passing the winning post.

The Jockey is permitted to ride work during his period of suspension.

The Jockey was informed of his right to appeal to The Board of Appeal in terms of Rule no.46(a).

6th Race: 30. The Noble Eagle Handicap - (About) 1000 metres. Horses rated 40 to 65 (12 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for CONSTANT VARIABLE (M.S.Deora) and GINSBURG (Shrikant Kamble) at both trainer's risk and liability.

GINSBURG (Shrikant Kamble) planted. Starting Stall Certificate revoked.

Jockey M.S.Deora rider of (CONSTANT VARIABLE) was observed to lose his reigns passing the 400 metres and regained them passing the 350 metres.

The Club's Veterinary Officer reported after the race that no abnormalities were found on FIRST EMPRESS (Sah Farid Ansari).

Routine Sample was taken for analysis from the winner CONSTANT VARIABLE (M.S.Deora).

The Stipendiary Stewards reported Jockey M.S.Deora, the rider of CONSTANT VARIABLE to the Stewards after the last race:

The Stewards after viewing the CCTV replay of the race multiple times, considering the statement of the Stipendiary Stewards and after having questioned Jockey M.S.Deora the rider of CONSTANT VARIABLE came to a conclusion that the Jockey was in breach of Rule 161(i) of the Madras Race Club Rules of Racing and resolved as follows:

To suspend Jockey M.S.Deora with effect from 20th November 2022 upto 1st December 2022(both days inclusive) for breach of Rule 161(i) of The Madras Race Club Rules of Racing for careless riding on his mount CONSTANT VARIABLE in Race no.30 run on 10th November 2022, wherein

- i.) Firstly passing the 800 metres he shifted in sharply causing interference to RHIANNON (Md.Farhan Alam) who had to check his mount and shift in, resulting in severe interference to ALEXANDER (Y.S.Srinath),travelling on his inside, who stumbled causing a check to SUCCESSION (Yash Narredu) travelling on the inner rails, the latter dropping back by over 3 lengths.
- ii.) Thereafter again shifting in sharply under use of the whip causing interference to PIRATE'S LOVE (Vivek G) travelling on the inner rails passing the 200 metres.

The Jockey is permitted to ride work during his period of suspension.

The Jockey was informed of his right to appeal to The Board of Appeal in terms of Rule no.46(a).

7th Race: 31. The Algeciras Handicap - Div. I - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for LADY CADET (Y S Srinath) at both trainer's risk and liability.

Permission was granted to Trainer R.Ramanathan to deputise on behalf of Trainer James Mckeown for LA JEFA (S.Antony Raj) at both trainer's risk and liability.

Trainer J.Sebastian was informed not to accept with his charge SUPREME DANCE (Dharshan Antony) until its behaviour improved to the satisfaction of the Stipendiary Stewards in 2 mock races on the race track on a race day.

The Club's Veterinary Officer reported after the race that LADY CADET (Y S Srinath) had sustained superficial injury on Right hind fetlock.

Routine Sample was taken for analysis from the winner LADY CADET (Y S Srinath).

The Stipendiary Stewards reported Jockey Dharshan Antony, the rider of SUPREME DANCE to the Stewards after the last race:

The Stewards after viewing the CCTV replay of the race multiple times, considering the statement of the Stipendiary Stewards and after having questioned Jockey Dharshan Antony the rider of SUPREME DANCE came to a conclusion that the Jockey was in breach of Rule 161(i) of the Madras Race Club Rules of Racing and resolved as follows:

Considering that Jockey Dharshan Antony is already suspended under the MRC Rules of Racing from 20th November 2022 to 10th December 2022 to further suspend Jockey Dharshan Antony with effect from 11th December 2022 upto 16th December 2022(both days inclusive) for breach of Rule 161(i) of The Madras Race Club Rules of Racing for careless riding on his mount SUPREME DANCE in Race no.31 run on 10th November 2022, wherein:

- i.) When the start was affected the Jockey allowed long reins resulting in his mount jumping outwards and causing interference to CYNOSURE (Neeraj Rawal) drawn 2, thereafter for further allowing his mount to shift out sharply causing interference to CARNOUSTIE (A.Ayaz Khan), GINGERSNAP(Vivek G), LA JEFA(S Antony Raj),KINGS WALK(S Kabdhar) and the worst affected being SPORTING SPIRIT(Yash Narredu) who stumbled momentarily unbalancing the rider.
- ii.) Thereafter for shifting out sharply under use of the whip bumping and causing interference to SPORTING SPIRIT (Yash Narredu) and simultaneously causing a check to PRICELESS BEAUTY(S.A.Amit) travelling on SUPREME DANCE's near hind quarters passing the 250 metres.

The Jockey is permitted to ride work during his period of suspension.

The Jockey was informed of his right to appeal to The Board of Appeal in terms of Rule no.46(a).

8th Race: 32. The Algeciras Handicap - Div. II - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).

Permission was granted to Trainer G. S. Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for WINDERMERE (Shrikant Kamble) at both trainer's risk and liability.

Permission was granted to Trainer R.Ramanathan to deputise on behalf of Trainer James Mckeown for RUBIROSA (S.Antony Raj) at both trainer's risk and liability.

WINDERMERE (Shrikant Kamble) was permitted to be withdrawn before coming under the starter's orders as the gelding was observed to have splayed his left hind shoe before loading procedures.

Jockey R Manish, the rider of KUNDAVAI was fined a sum of Rs 2000/- for shifting in passing the 800 metres when not sufficiently clear causing a check to LADY LUCK (Neeraj Rawal) travelling on the inner rails.

The Club's Veterinary Officer reported after the race that no abnormalities were found on KUNDAVAI (R Manish).

The Club's Veterinary Officer reported after the race that RUBIROSA (S.Antony Raj) suffered from EIA (Exercise induced arrhythmia) before sample was tested .

Routine Sample was taken for analysis from the winner RUBIROSA (S.Antony Raj) .

BHAIRAVA'S QUEEN (P.S.Kaviraj) Jumped awkwardly.

2nd Race: 26. The Antonios Handicap (About) 1800 Metres

CHEVAL BLANC (S.Antony Raj) Jumped awkwardly.

3rd Race: 27. The Diego Riveira Handicap - Div. II (About) 1200 Metres

DANCING GRACE (C A Brisson) Slowly away.
MAGICAL WAVE (Dharshan Antony) Fly jumped awkwardly.
SACRE COUER (Neeraj Rawal) Jumped awkwardly.

4th Race: 28. The Diego Riveira Handicap - Div. I (About) 1200 Metres

ATTENBOROUGH (P.S.Kaviraj) and WINDSOR WALK (Ram Nandan Manjhi) Jumped awkwardly.

IGNITION (L.Alex Rozario) Fly jumped awkwardly.
ANATOLIA (S.Antony Raj) Lost about a couple of lengths.

5th Race: 29. The Supervite Handicap (About) 1400 Metres

ANGEL HEART (S.A.Amit) Fly jumped awkwardly.

6th Race: 30. The Noble Eagle Handicap (About) 1000 Metres

FIRST EMPRESS (Sah Farid Ansari) Fly jumped awkwardly.
GINSBURG (Shrikant Kamble) Planted.SSC revoked.
DEMERARA (Angad) Lost about a couple of lengths. Advised one gate practise.

7th Race: 31. The Algeciras Handicap - Div. I (About) 1400 Metres

SUPREME DANCE (Dharshan Antony) Jumped awkwardly and veered out. Advised two mock races.
CYNOSURE (Neeraj Rawal) Lost about a length.

8th Race: 32. The Algeciras Handicap - Div. II (About) 1400 Metres

LADY LUCK (Neeraj Rawal) and KUNDAVAI (R Manish) Jumped awkwardly.
