

## <u>MADRAS RACES 2022-2023</u> <u>TWENTY SIXTH DAY,SATURDAY,4thFEBRUARY,2023</u> <u>RACING INCIDENTS</u> (162-167)

TRACK CONDITION:GOODGOINGPENETROMETER READING:3.2 CMSRAILING POSITION:RAILINGS PLACED AT AN AVERAGE WIDTH OF 7 METRESFROM 1200 METRES TILL THE WINNING POST FROM ITS ORIGINAL POSITION

## <u>1st Race: 162. THe Baroda Handicap - (About) 1100 metres. Horses rated 20 to 45(Whips not allowed) (8 Runners).</u>

GREAT SPIRIT (M Bhaskar) was permitted to be withdrawn on veterinary grounds as the filly was observed to be trotting lame on both hind due to acute sore back.Trainer DeepeshNarredu was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with her.

Permission was granted to Trainer AjithKumar.V to deputise on behalf of Trainer P.Krishna for PAPPA RICH (Koshi Kumar) at both trainer's risk and liability.

Permission was granted to Trainer Saddam Iqbal to deputise on behalf of Trainer Vishesh M. P. for SPARKLEBERRY (Md FarhanAlam) at both trainer's risk and liability.

PROTEA (Dharshan Antony) jumped awkwardly and was lugging in soon after the start. The Club's Veterinary Officer when asked to examine the mare reported after the race that no abnormalities were found. Trainer Dhruv Kumar Futnani was informed to take remedial measures before next accepting with her.

Jockey Md Farhan Alam, the rider of SPARKLEBERRY, Jockey S. Imran, the rider of TIFOSI, Jockey Dharshan Antony, the rider of PROTEA and Jockey YashNarredu, the rider of PLANET VENUS were fined a sum of Rs 1000/- each for carrying their whips to the paddock for a race where the use of whips was not allowed. The whips were withdrawn before they left the paddock.

Routine Sample was taken for analysis from the winner PLANET VENUS (YashNarredu).

## <u>2<sup>nd</sup> Race: 163. The Mr Prospector Handicap - Div. I - (About) 1400 metres. Horses rated 20 to</u> <u>45 (10 Runners).</u>

Permission was granted to Trainer AjithKumar.V to deputise on behalf of Trainer P.Krishna for TRENDING PRINCESS (P.S.Kaviraj) at both trainer's risk and liability.

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for HERRING (ShrikantKamble) at both trainer's risk and liability.

Jockey Dharshan Antony, the rider of REIGN OF TERROR was severely cautioned for trying to take a gap 50 metres after the start on the inner rails and unbalancing ROYAL BARON (M.S.Deora) in the process .

Jockey A Ayaz Khan, the rider of MAJESTIC WIND was fined a sum of Rs 1000/- for shifting in sharply soon after the start.

Jockey G Manikandan, the rider of SOUL MESSAGE was fined a sum of Rs 2000/- for shifting in negotiating the final bend at about the 500 metres, bumping and forcing in HERRING (ShrikantKamble) and thereafter shifting out bumping and forcing out TURF BEAUTY (SahFarid Ansari).Further SOUL MESSAGE (G Manikandan) was observed to have dropped back passing 550 metres.The Club's Veterinary Officer when asked to examine SOUL MESSAGE (G Manikandan) reported after the race that no abnormalities were found.Trainer Saddam Iqbal was informed to ensure his charge was capable of running with the field in future.

The Club's Veterinary Officer reported after the race that HERRING (ShrikantKamble) had sustained superficial injury on Right hind coronet.

Routine Sample was taken for analysis from the winner TERMINATOR (YashNarredu).

## <u>3<sup>rd</sup> Race: 164. The Quasar Handicap - (About) 1400 metres. Horses rated 40 to 65 (10 Runners).</u>

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for LADY CADET (Y S Srinath) at both trainer's risk and liability.

Permission was granted to Trainer Saddam Iqbal to deputise on behalf of Trainer Vishesh M. P. for BREAK THE SILENCE (Md FarhanAlam) at both trainer's risk and liability.

Jockey A.M.Tograllu, the rider of STORM FLAG was reprimanded for shifting in soon after the start inconveniencing ROYAL MONARCH (SahFarid Ansari).

Jockey YashNarredu, the rider of SONIC DASH reported that he felt something wrong with his mount and was hanging out for major part of the race. The Club's Veterinary when asked to examine the horse reported after the race that there were no abnormalities on physical examination, but the horse was non-cooperative for Endoscopy.

Jockey C A Brisson, the rider of SHEZ R STAR was reprimanded for dropping his hands before passing the post.

Routine Sample was taken for analysis from the winner LADY CADET (Y S Srinath).

## <u>4th Race: 165. The Surite Million - (About) 1100 metres. For Maiden Horses 3 Years old only (9 Runners).</u>

PURE FOR SURE (M Bhaskar) was permitted to be withdrawn on veterinary grounds as the filly was observed to be trotting lame on left hind due to sprained stifle.Trainer DeepeshNarredu was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with her.

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for CLOUDY HILLS (Dashrath Singh) at both trainer's risk and liability.

Jockey SurajNarredu, the rider of FONDNESS OF YOU was cautioned for shifting in soon after the start causing a check to SOFT WHISPER (P.Sai Kumar).

SOFT WHISPER (P.Sai Kumar) was observed to be running green throughout the race.

The Club's Veterinary Officer reported after the race that no abnormalities were found on REGENT PRINCE (SahFarid Ansari).

Routine Sample was taken for analysis from the winner FONDNESS OF YOU (SurajNarredu).

## 5<sup>th</sup> Race: 166. The Madras Gold Vase(Grade III) - (About) 1400 metres. For Indian Horses 3 Years old only (Foaled in 2020) (6 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for TIME AND TIDE (Y S Srinath) at both trainer's risk and liability.

Permission was granted to Trainer Ramanathan.R to deputise on behalf of Trainer James Mckeown for DAME FONTEYN (Dashrath Singh) at both trainer's risk and liability.

Permission was granted to Trainer Rajesh Narredu to deputise on behalf of Trainer S. Narredu for TOUCH OF GREY (SurajNarredu)at both trainer's risk and liability.

Jockey R N Darshan, the rider of LAND OF GOLD reported that his mount did not respond throughout the race. The Club's Veterinary Officer when asked to examine the gelding reported after the race that he was found to be trotting lame on Right fore due to sore shin. Further the gelding suffered from exhaustion during the race.

TIME AND TIDE (Y S Srinath) was observed to brush the inner railings passing the 100 metres.

Compulsory samples were taken for analysis from the following TOUCH OF GREY (SurajNarredu) the winner, TIME AND TIDE (Y S Srinath) placed II & MULTIWAVE (P.Sai Kumar) placed III.

## <u>6<sup>th</sup> Race: 167. The Mr Prospector Handicap - Div. II - (About) 1400 metres. Horses rated 20 to</u> <u>45 (9 Runners).</u>

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Adhiraj Singh Jodha for ATTENBOROUGH (ShrikantKamble) at both trainer's risk and liability.

WISAKA (SahFarid Ansari) threw its head and jumped awkwardly outwards inconveniencing ATTENBOROUGH (ShrikantKamble) who was slow to start by a length.

Jockey Dharshan Antony, the rider of WINDSOR WALK was fined a sum of Rs.2000 was not maintaining sufficient efforts to prevent his mount from shifting out immediately after the start, further shifting out forcing out and causing interference to SUPER GLORY (R Manish) who further shifted out onto WISAKA (SahFarid Ansari)

Jockey S.Imran, the rider of IGNITION was fined a sum of Rs.2000 for shifting out from the inner rails passing the 1200 metres causing SUPER GLORY (R Manish) travelling directly behind to clip the heels of IGNITION (S.Imran) and drop back, losing considerable ground and thereafter ran detached.

Jockey P.S.Kaviraj, the rider of SACRE COUER was fined a sum of Rs.1000 for not making sufficient efforts to prevent his mount from lugging in and causing interference to PARIS O'CONNOR (P.Sai Kumar) travelling to his inside on the inner rails passing the 850 metres, the latter dropping back by a few lengths.

WISAKA (SahFarid Ansari) was observed to drift out passing the 300 metres and further drifted wide out onto the outer rails where it ran till the post. Trainer Saddam Iqbal was informed to take remedial measures before next accepting with his charge.

The Club's Veterinary Officer reported after the race that no abnormalities were found on SUPER GLORY (R Manish).

Routine Sample was taken for analysis from the winner WISAKA (SahFarid Ansari).

TRENDING PRINCESS (P.S.Kaviraj) and TURF BEAUTY (SahFarid Ansari) Lost about a length. MAJESTIC WIND (A Ayaz Khan) Jumped awkwardly. REIGN OF TERROR (Dharshan Antony) Slowly away.

## 3rd Race: 164. The Quasar Handicap (About) 1400 Metres

BREAK THE SILENCE (Md FarhanAlam) and STAR SYMBOL (S Kabdhar) Jumped awkwardly. ROMUALDO (P.S.Kaviraj) Fly jumped awkwardly.

## 4th Race: 165. The Surite Million (About) 1100 Metres

SOFT WHISPER (P.Sai Kumar) and FONDNESS OF YOU (SurajNarredu) Jumped awkwardly.

## 5th Race: 166. The Madras Gold Vase (About) 1400 Metres

TOUCH OF GREY (SurajNarredu) Jumped awkwardly.

## 6th Race: 167. The Mr Prospector Handicap - Div. II (About) 1400 Metres

WINDSOR WALK (Dharshan Antony) and SUPER GLORY (R Manish) Jumped awkwardly. WISAKA (SahFarid Ansari) Fly jumped awkwardly.
