RAILINGS POSITION:RAILINGS ARE PLACED AT ITS ORIGINAL POSITION.

1st Race: 95. The Sea Bird Handicap - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (10 Runners).

Permission was granted to Trainer G.S.Parmar to deputise on behalf of Trainer Vishesh M. P. for CLOUD JUMPER at both trainer's risk and liability.

Permission was granted to Trainer Fahad Khan to deputise on behalf of Trainer Adhiraj Singh Jodha for LISTEN TO ME (P.S.Kaviraj) at both trainer's risk and liability.

Permission was granted to Trainer P.Krishna to deputise on behalf of Trainer Dr.Anil Kumar for MUSANDA (A Ayaz Khan) at both trainer's risk and liability.

LISTEN TO ME (P.S.Kaviraj) Jumped awkwardly outwards and MUSANDA (A Ayaz Khan) jumped awkwardly inwards bumping into each other and causing interference to MYSTICAL MAGICIAN (Ram Nandan Manjhi).

DAZZLING PRINCESS (M.S.Deora) was hanging in throughout, The Club's Veterinary Officer when asked to examine the filly reported after the race that she was found to have injuries on buccal mucosa in Right side. Trainer P.Krishna was advised to take remedial measures before next accepting with it.

MYSTICAL MAGICIAN (Ram Nandan Manjhi) trailed the field, ran detached .The Club's Veterinary Officer when asked to examine the gelding reported after the race that no abnormalities were found..

STAR OF LIBERTY (Shyam Kumar) stopped galloping passing the 250 metres, shifted in tightening and forcing in TIFOSI (P.Sai Kumar) onto MUSANDA (A Ayaz Khan) travelling on the inner rails. Trainer R.Foley was asked to ensure that his charge was capable of running with the field.

The Club's Veterinary Officer reported after the race that no abnormalities were found on CLOUD JUMPER (C A Brisson) and MUSANDA (A Ayaz Khan) .

Routine Sample was taken for analysis from the winner WOOD ART (C Umesh) .

2nd Race: 96. The Parson Valley Handicap - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (9 Runners)

QUEEN ANULA (Ashhad Asbar) jumped awkwardly outwards onto MR MOZART (C A Brisson) at the start inconveniencing the latter.

MR MOZART (C A Brisson) lacked initial speed and thereafter ran detached. The Club's Veterinary Officer when asked to examine the gelding reported after the race that no abnormalities were found.

Jockey Mohit Singh, the rider of WINDSOR WALK reported that he accidentally lost the whip 100 metres before the winning post.

Jockey Sah Farid Ansari, the rider of NIGHTJAR was severely cautioned for not making sufficient efforts to prevent his mount from shifting in. The Club's Veterinary Officer reported after the race that no abnormalities were found.

Jockey Mohit Singh, the rider of WINDSOR WALK was severely cautioned for not making sufficient efforts to prevent his mount from shifting out negotiating the 800 metre bend forcing out QUEEN ANULA (Ashhad Asbar).

Routine Sample was taken for analysis from the winner BOHEMIAN STAR (P.Sai Kumar).

3rd Race: 97. The Snoot Handicap - (About) 1300 metres. Horses rated 00 to 25 (10 Runners).

Permission was granted to Trainer P.Krishna to deputise on behalf of Trainer Dr.Anil Kumar for CAIRO (A Ayaz Khan) at both trainer's risk and liability.

CAIRO (A Ayaz Khan) lacked initial speed, trailed the field and ran detached. Trainer Dr.Anil Kumar was informed not to accept with his charge until its behaviour improved to the satisfaction of the Stipendiary Stewards in a mock race on the race track on a race day. The Club's Veterinary Officer reported after the race that the filly had laryngeal abnormality(ILH-gr3).

Jockey M.S.Deora, the rider of LITTLE WONDER reported that his mount was slow to start and lacked initial speed.

Jockey Mohit Singh, the rider of ROYAL SYMBOL reported that his mount was lugging in throughout the race. The Club's Veterinary Officer when asked to examine the filly reported after the race that no abnormalities were found.

The Club's Veterinary Officer reported after the race that no abnormalities were found on SUNNY ISLES (P.S.Kaviraj) and STAR OF TEXAS (Khet Singh).

The Club's Veterinary Officer reported after the race that OCEAN LOVE (Ram Nandan Manjhi) had sustained superficial injury on Right hind coronate.

Routine Sample was taken for analysis from the winner LITTLE WONDER (M.S.Deora).

4th Race: 98. The Magnolia Handicap - Div. I - (About) 1300 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

WAKANDA (Dharshan Antony) had sustained injury on Left hind fetlock and was permitted to be withdrawn on veterinary grounds. Trainer K. S. Mandanna was informed to get his charge certified fit by the Club's Veterinary Officer before next accepting with it.

Permission was granted to Trainer P.Krishna to deputise on behalf of Trainer Dr.Anil Kumar for EAGLE BLUFF (A Ayaz Khan) at both trainer's risk and liability.

Jockey Ashhad Asbar, the rider of SPEED AIR reported that his mount was slowly off at the start and stumbled at 800 meters while negotiating the bend. The Club's Veterinary Officer when asked to examine the gelding reported after the race that no abnormalities were found.

Jockey P.S.Kaviraj, the rider of GALLANTRY was fined a sum of Rs 2000/- for shifting out under use of the whip bumping and causing interference to RHIANNON (M.S.Deora) in the final stages of the race

An Objection was lodged by Jockey M.S.Deora, the rider of RHIANNON placed 4th by the Judge against Jockey P.S.Kaviraj, the rider of GALLANTRY placed 3rd by the Judge for "*In the straight after passing 200 meters GALLANTRY came in sharply, I got unbalanced and my stride was broken due to which I lost a certain race*". The Stewards interviewed both the Jockeys and after viewing the CCTV replay of the race decided to overrule the objection, with no change in the order of placings as declared by the Judge.

Routine Sample was taken for analysis from the winner AMBER LIGHTNING (Sah Farid Ansari) .

5th Race: 99. The Magnolia Handicap - Div. II - (About) 1300 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

Permission was granted to Trainer Fahad Khan to deputise on behalf of Trainer Adhiraj Singh Jodha for GINSBURG (M.S.Deora) at both trainer's risk and liability.

LADY ROYAL (C Umesh) was hanging in, in the final stages of the race.

Routine Sample was taken for analysis from the winner LADY ROYAL (C Umesh).

6th Race: 100. The Admiration Handicap - Div. I - (About) 1400 metres. Horses rated 60 to 85 (8 Runners).

Permission was granted to Trainer Ramanathan .R to deputise on behalf of Trainer James Mckeown for RUBIROSA (C Umesh) at both trainer's risk and liability.

Permission was granted to Trainer Fahad Khan to deputise on behalf of Trainer Adhiraj Singh Jodha for WINDERMERE (Shrikant Kamble) at both trainer's risk and liability.

EMPRESS ETERNAL (Sah Farid Ansari) and ILLUSTRIOUS RULER (Shyam Kumar) both, fly jumped at the start, losing about 2 to 3 lengths.

The Club's Veterinary Officer reported after the race that no abnormalities were found on LORDSHIP (Md Farhan Alam) and BERRETTINI (Mohit Singh)

Routine Sample was taken for analysis from the winner RUBIROSA (C Umesh).

7th Race: 101. The Admiration Handicap - Div. II - (About) 1400 metres. Horses rated 60 to 85 (9 Runners).

Permission was granted to Trainer P.Krishna to deputise on behalf of Trainer Dr.Anil Kumar for IGNORANCE IS BLISS (P.S.Kaviraj) at both trainer's risk and liability.

Jockey Mohit Singh, the rider of KINGS WALK reported that his mount was hanging in severely throughout the race, further drifted in entering the straight inconviencing HALLUCINATE (Sah Farid Ansari) and ANGEL HEART (M.S.Deora). The Club's Veterinary Officer when asked to examine KINGS WALK (Mohit Singh) reported after the race that no abnormalities were found.

Routine Sample was taken for analysis from the winner DARK SON (P.Sai Kumar).

8th Race: 102. The Harbinger Handicap - (About) 1500 metres. Horses rated 20 to 45, 6 years old and over (8 Runners).

Permission was granted to Trainer P.Krishna to deputise on behalf of Trainer Dr.Anil Kumar for SUPARAKIGA (P.Sai Kumar) at both trainer's risk and liability.

SEA SCRIPT (Khet Singh) jumped awkwardly at the start losing about 3 lengths in the process.

Routine Sample was taken for analysis from the winner WONDERFUL ERA (C Umesh).

OVERWEIGHTS CARRIED ON 20TH MAY,2023:

3rd Race: 97. The Snoot Handicap - (About) 1300 metres. Horses rated 00 to 25 (10 Runners).

Jockey Khet Singh, the rider of STAR OF TEXAS carried an overweight of 1& 1/2 kgs.

2nd Race: 96. The Parson Valley Handicap (About) 1200 Metres

WINDSOR WALK (Mohit Singh) and QUEEN ANULA (Ashhad Asbar) Jumped awkwardly.

3rd Race: 97. The Snoot Handicap (About) 1300 Metres

LITTLE WONDER (M.S.Deora) Slolwy away.

OCEAN LOVE (Ram Nandan Manjhi) Jumped awkwardly.

4th Race: 98. The Magnolia Handicap - Div. I (About) 1300 Metres

SPEED AIR (Ashhad Asbar) Slowly away.

EAGLE BLUFF (A Ayaz Khan) Lost about 4 lengths.

5th Race: 99. The Magnolia Handicap - Div. II (About) 1300 Metres

LADY ROYAL (C Umesh) Jumped awkwardly.

GINSBURG (M.S.Deora) Slowly away.

ANNEXED (Mohit Singh) Lost about a length.

WAYTOGO (Khet Singh) very fractious inside the stall.

6th Race: 100. The Admiration Handicap - Div. I (About) 1400 Metres

EMPRESS ETERNAL (Sah Farid Ansari) Fly jumped awkwardly and lost about a couple of lengths.

ILLUSTRIOUS RULER (Shyam Kumar) Jumped awkwardly.

7th Race: 101. The Admiration Handicap - Div. II (About) 1400 Metres

HALLUCINATE (Sah Farid Ansari) Slowly away.

8th Race: 102. The Harbinger Handicap (About) 1500 Metres

SEA SCRIPT (Khet Singh) Jumped awkwardly.

ICY RIVER (A Ayaz Khan) Slowly away.
