RACING INCIDENTS**

(25-30)

TRACK CONDITION : GOOD TO SOFT

PENETROMETER READING : 4.00CMS

RAILINGS POSITION : RAILINGS ARE PLACED AT AN AVERAGE WIDTH OF 7 METRES FROM 1200 METRES UPTO THE WINNING POST FROM ITS ORIGINAL POSITION.

1st Race: 25. The Hail To Reason Handicap - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

STERN MAIDEN (K V Baskar) veered out in the straight onto AUTUMN SHOWER (Koshi Kumar).

Jockey Yash Narredu, the rider of GREAT SPIRIT was reprimanded for coming in sharply onto TRUMP BABY (Hindu Singh) at the 300 metres where TRUMP BABY (Hindu Singh) had to be steadied to avoid clipping. Jockey Yash Narredu, the rider of GREAT SPIRIT was advised to be more cautious in future.

The Club's Veterinary Officer reported after the race that no abnormalities were found on THRILL OF POWER (P.Vikram) .

Routine Sample was taken for analysis from the winner GREAT SPIRIT (Yash Narredu) .

2nd Race: 26. The Hail To Reason Handicap - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

EMPRESS ROYAL (Sah Farid Ansari) and ANNEXED (Md Farhan Alam) planted.

The Club's Veterinary Officer reported after the race that no abnormalities were found on ANNEXED (Md Farhan Alam).

Routine Sample was taken for analysis from the winner KING ROGER (Hindu Singh).

3rd Race: 27. The Turn-To Handicap - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

As the start was effected QUEEN OF FAME (Ramandeep Singh) came in causing interference to TIFOSI (S.Imran) drawn 5 onto DESERT STAR (Inayat) drawn 4 by which DESERT STAR (Inayat) had to be steadied losing ground at the start.

Trainer N. Govindarajan was called in to explain the poor performance of MR STARC (P Surya) and TIFOSI (S.Imran).Explanation was noted and he was advised to be more careful in accepting his wards in future.

The Club's Veterinary Officer reported after the race that no abnormalities were found on MR STARC (P Surya) and DESERT STAR (Inayat).

The Club's Veterinary Officer reported after the race that CLOUDY HILLS (Suraj Narredu) was suffering from sore back. Trainer Suraj Prasad Shaw was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next to race.

The Club's Veterinary Officer reported after the race that TIFOSI (S.Imran) had sustained superficial injury on Right hind fetlock and was initially found to have laryngeal abnormality.

Routine Sample was taken for analysis from the winner LORD MOI (S.Antony Raj).

4th Race: 28. The Nasrullah Handicap - (About) 1600 metres. Horses rated 40 to 65 (9 Runners).

The Club's Veterinary Officer reported after the race that no abnormalities were found on CAPE WICKHAM (C A Brisson).

The Club's Veterinary Officer reported after the race that ROYAL BARON (Inayat) was suffering from sore back.Trainer B.Suresh was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next to race.

Routine Sample was taken for analysis from the winner MISS ALLURE (Yash Narredu) .

5th Race: 29. The Galileo Handicap - (About) 1100 metres. Horses rated 60 to 85, 4 years old and over (10 Runners).

PRICELESS RULER (Md Farhan Alam) got stuck inside the gates resulting in contusion to the left fore elbow and was withdrawn before coming under the starter's order. Trainer R.Foley was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next to race.

TIMELESS ROMANCE (Sah Farid Ansari) planted and took no part in the race. The Club's Veterinary Officer reported after the race that no abnormalities were found.

KAY STAR (Hindu Singh) jumped out awkwardly.

Jockey (C.A.Brisson), the rider of BERRETTINI reported that his horse was hanging in the top of the straight and when corrected with the use of the whip started to veer out to the left.

Routine Sample was taken for analysis from the winner AMAZONIA (Yash Narredu).

6th Race: 30. The See The Stars Handicap - (About) 1200 metres. Horses rated 40 to 65 (10 Runners).

Jockey Ram Nandan Manjhi, the rider of GROOVIN (drawn 5) was called and interviewed by the Chief Stipendiary Steward. He informed his instructions were to sit well up and do his best in the straight. When he was shown the replay of the race and asked to show his effort in the early part of the race. He was warned to be more careful in positioning and riding to their instructions.

Trainer Suraj Prasad Shaw was called and questioned into the running and riding of GROOVIN (Ram Nandan Manjhi) and his explanation was noted.

Routine Sample was taken for analysis from the winner MONTELENA (Suraj Narredu).

OVERWEIGHTS CARRIED ON 21ST OCTOBER 2023:

3rd Race: 27. The Turn-To Handicap - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

Jockey Inayat, the rider of DESERT STAR carried an overweight of 1kg.

4th Race: 28. The Nasrullah Handicap - (About) 1600 metres. Horses rated 40 to 65 (9 Runners).

Jockey Sah Farid Ansari, the rider of FELIX carried an overweight of 1/2 kg.

1st Race: 25. The Hail To Reason Handicap - Div. II (About) 1200 Metres

AUTUMN SHOWER (Koshi Kumar) Fly jumped awkwardly.

2nd Race: 26. The Hail To Reason Handicap - Div. I (About) 1200 Metres

ANNEXED (Md Farhan Alam) and EMPRESS ROYAL (Sah Farid Ansari) Lost about 3-4 lengths. Advised two gate practices.

3rd Race: 27. The Turn-To Handicap (About) 1400 Metres

DESERT STAR (Inayat) Jumped out awkwardly.

LORD MOI (S.Antony Raj) was Slowly away.-

4th Race: 28. The Nasrullah Handicap (About) 1600 Metres

LOCH LOMOND (S.Antony Raj) was Slowly away.

5th Race: 29. The Galileo Handicap (About) 1100 Metres

TIMELESS ROMANCE (Sah Farid Ansari) Planted.SSC revoked. PRICELESS RULER (Md Farhan Alam) Very fractious and played up inside the stalls, was Withdrawn on veterinary grounds. Advised two gate practices.

KAY STAR (Hindu Singh) Fly jumped awkwardly.

6th Race: 30. The See The Stars Handicap (About) 1200 Metres

Level Jump.

YAZH (R.S.Bhati) was Very reluctant to be stalled. Advised one gate practice

ADDITIONAL REPORT

ORDER OF THE STEWARDS

(a) Race No 9 “The Avalanche Handicap” run on Monday 8th April 2023 at Udhagamandalam.

The Stewards at their meeting held on Saturday 30th September 2023 considered the Charge No 35 issued to Trainer G.S.Parmar with respect to his horse ch.g.7 yr old “ HARAN” having tested positive for Norketamine and Dehydronorketamine in Race No 9 “The Avalanche Handicap”run on Monday ,8th April 2023 at Udhagamandalam. The drug listed under class II of the Medication Rules.

The Stewards after hearing Trainer G.S.Parmar, deliberated the matter in length along with the Stipendiary Stewards and Chief Veterinary Officer and decided to suspend Trainer G.S.Parmar’s licence under Rule no 202(1) of MRC rules of racing and Rule no 23 of Medication Rules for a period of 2 months from 1st October 2023 to 30th November 2023(both days inclusive)

The Trainer was informed of his right to appeal to the Board of Appeal in terms of Rule no **46(a)**.

(b). Race No 113 “The Almanzor Handicap” run on Thursday, 25th May 2023 at Udhagamandalam for Dangerous and Foul Riding.

The Stewards at their meeting held on Saturday 30th September 2023 considered the Charge No 36 issued to Apprentice Jockey Dharshan Antony for his dangerous and foul riding on his mount “Maranello” and causing severe interference to “War Emblem” ridden by Jockey A M Alam in Race no 113 “ The Almanzor Handicap” run on Thursday 25th May 2023 at Udhagamandalam.

The Stewards deliberated the matter in length and after viewing CCTV replay of the above race multiple times and having discussed the matter with Stipendiary Stewards who alleged App Jockey Dharshan Antony had committed breach of liable for action under rule no 161(1) of MRC rules of racing for dangerous and foul riding.

The Stewards after hearing Apprentice Jockey Dharshan Antony who made his submissions and taking into consideration all factors decided to warn him to be more careful in his future riding engagements so as to avoid any danger to other jockeys in a race.

(c).For using an unapproved Body protector (Duplicate) with a Malicious Intention to cheat the riding weight.

The Stewards perused the charge sheet no 36 issued to Apprentice Jockey Dharshan Antony by MRC Stipendiary Stewards alleging that Jockey Dharshan Antony had committed breach of /liable for action under rule no 144(b) of Madras Race Club rules of racing by using an unapproved body protector with a malicious intention to cheat the weight.

The Stewards after hearing the submissions made by Apprentice Jockey Dharshan Antony who admitted that he was using unapproved body protector, deliberated the matter along with Stipendiary Stewards taking into account that the omission had been detected prior to weighing out by the Apprentice Jockey and the intention to cheat had not been technically committed ,decided to impose a fine of Rs 20,000/ for using an unapproved body protector thereby infringing rule no 144(b)of MRC rules of racing and also warned him not to use an un- approved protector which involves enormous risk for himself apart from infringing the rules of racing.

(d).AN ENQUIRY INTO THE CHARGE SHEET NO 037 ISSUED TO TRAINER P.KRISHNA ON BREACH OF MEDICATION RULES.

The Stewards at their meeting held on Saturday 14th Oct 2023 after the last race the charge sheet issued to Trainer P Krishna and considering all papers and proceedings before them and also having heard the submissions made by Trainer P Krishna, Chief Stipendiary Steward and Chief Veterinary officer.

After deliberations, the Stewards were not satisfied with the explanation tendered by Trainer P.Krishna and held him guilty of breach of medication rules of Madras Race Club and unanimously decided to:

- a.).To withdraw the license granted to Trainer P.Krishna and to treat him as **Disqualified Person** for a period of two years from **15th October 2023 to 14th October 2025** both days inclusive for breaching rule **202(i),and 202(x)(a) & (b)of MRC Rules of Racing** and under medication **Rule number 6, Rule no 12(i),Rule No 13 (a)(c)(f)(g)(h) Rule no 14,Rule no 17, Rule no 23(a)(b)(c), Rule no 25(1,2,3) Rule no 26(i),27(a,b,c)** for possession of syringes, substances, administrable medicines, fluids under violation of medication rules.
- b) And he will not be permitted to enter any race course in India or attend any race meeting, horse stable area or attend track work during his disqualification.

In view of the aforesaid and in pursuance of the Rules of Racing and Calendar notification under the heading “**Disqualified Person**”.

The Trainer was informed of his right to appeal to the Board of Appeal.
