**1<sup>st</sup> Race: 45. The Upper Bhavani Handicap - (About) 1200 metres. Horses rated 00 to 25 (9 Runners)**

During Veterinary examination on 28/04/2024 at 8.26am, FASHIONISTA (Ramandeep Singh) was suffering from Right fore tendinitis resulting in lameness. Trainer K. S. Mandanna was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

UGLY TRUTH (C Umesh) slowly away losing about a length at the start.

ALETTA (Soufyane J Moulin) had to be checked at about 900 metres due to incoming DAIYAMONDO (Koshi Kumar) and stumbled, and also received a clip injury at the left hind from ROYAL SUPREMACY (Ram Nandan Manjhi) who was turning at the right handed turn.

The Club's Veterinary Officer reported after the race that ALETTA (Soufyane J Moulin) had sustained superficial injury on left Gaskin.

Routine Sample was taken for analysis from the winner UGLY TRUTH (C Umesh).

**2<sup>nd</sup> Race: 46. The Teofilo Handicap - (About) 1200 metres. Horses rated 20 to 45(Whips not allowed) (9 Runners).**

The Club's Veterinary Officer reported after the race that DIVINE DAWN (Surya Prakash) had pulled up lame on Left fore during the race. Trainer Ramanathan R was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

During veterinary treatment at 6.05am on 24th April 2024, MORISET was suffering from Colic. Trainer B.Suresh was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

The Club's Veterinary Officer when asked to examine ANDORRA (C Umesh) and RULING STAR (S.A.Amit) reported after the race that no abnormalities were found,

The Club's Veterinary Officer when asked to examine RED SEA STAR (Dharshan Antony) reported after the race, that the horse was suffering from sore back. Trainer K. S. Mandanna was informed to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

### **ORDER OF THE STEWARDS**

#### **ENQUIRY INTO THE RUNNING AND RIDING OF “MULTICROWN ” (DRAWN 3 ) IN RACE NO. 36 – THE MYSTICAL HANDICAP (DIST. 1400 MTRS.) RUN ON SUNDAY, 21st APRIL 2024 :**

In connection with the captioned subject matter, the Stewards of the Club at their meeting held in the weighing room Madras Race Club, Hobart Park, Udthagamandalam at 3.30 pm on Saturday 27th April 2024 considered all the papers and proceedings before them and having heard the submissions made by Jockey Nakhat Singh and Trainer B Suresh , as also the Chief Stipendiary Steward. Having viewed the video recordings of (Race No 6 Winner- MULTICROWN) the way and vigour he had ridden to win and in comparison to race no 36 , The Mystical Handicap where he finished fourth, after carefully deliberated the submissions made by Jockey Nakhat Singh and the observation of Trainer B Suresh , the Stewards of the Club were not satisfied with the explanation tendered by Jockey Nakhat Singh and held him guilty of not permitting his mount "MULTICROWN" (Race No 36) to run on its merits for contravening rule 159 (a)(b) and 161(ii) of MRC rules of racing. Thus

-For not allowing the horse to run on its merit

-For not positioning and placing his mount to an advantage at any time of the race

-For not showing any vigour and intention to improve and not riding out to the fullest.

Therefore, the Stewards of Madras Race Club decided to withdraw his“B” Jockeys Licence issued to Jockey Nakhat Singh with effect from 16th May 2024 upto 31st December 2024, both the days inclusive and declare Jockey Nakhat Singh as a disqualified person and shall be subject to all disabilities under MRC Rules of Racing for a disqualified person.

Please note that during the period of his punishment:

- a) He is not permitted to ride work;
  - b) He is not permitted to attend racing, on course or off course;
  - c) He is not permitted to enter the stable area at any Turf Authority of India.
- The Jockey was informed of his right of appeal to the Board of Appeal in terms of Rule no 46(a).
