

### MADRAS RACES 2024-2025 3RD DAY, SATURDAY, 14TH SEPTEMBER 2024 RACING INCIDENTS (14-19)

TRACK CONDITION : GOOD GOING PENETROMETER READING: 3.20 CMS

RAILINGS POSITION : NO FALSE RAILS

## 1st Race: 14. The Hover Craft Handicap - Div. II - (About) 1100 metres. Horses rated 00 to 25, 4 years old and over (8 Runners).

Soon after the jump ASHWA DEV drawn - 7 (A.M.Tograllu) gradually shifted in and RWANDA (Koshi Kumar drawn-3) who in turn went on to BLUE SAPPHIRE (R Manish drawn-1) causing latter who got tightened and dropped back. Jockey A.M. Tograllu and Apprentice Jockey Koshi Kumar, were both cautioned.

Routine Sample was taken for analysis from the winner CONSCIOUS KEEPER (Apprentice Darshan.N).

## 2<sup>nd</sup> Race: 15. The Hover Craft Handicap - Div. I - (About) 1100 metres. Horses rated 00 to 25, 4 years old and over (8 Runners).

During routine Veterinary Examination on 13/09/24 at 9.38 am ANNALISA (Shah Alam)was observed to be trotting lame on left fore due to sprained fetlock and was permitted to be withdrawn on veterinary grounds. Trainer Fahad Khan was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Soon after the start ,THE STING (A S .Peter drawn -6) jumped outwards and went on to EMPIRE OF DREAMS (M.S.Deora drawn -5) who had to check at the same time STOLEN GLANCE (Shankar Lal H) shifted due to which AUTUMN LIGHT (A.M.Tograllu) racing between was tightened for room had to be steadied. Jockey A S .Peter, was cautioned.

ROYAL MAYFAIR (Sah Farid Ansari) drifted out alarmingly in the straight despite Jockey's effort. The Club's Veterinary Officer was asked to examine the mare, who reported after the race that no abnormalities were found.

An Enquiry was opened into the running and riding of EMPIRE OF DREAMS trained by Suraj Prasad Shaw. And ridden by Jockey M.S.Deora

Routine Sample was taken for analysis from the winner KNOTTY POWER (Apprentice Darshan.N).

An Enquiry was held by the Stipendiary Stewards into the Running and Riding of "EMPIRE OF DREAMS" on Sunday,14-09-24 at 4.30 p.m.

#### THE HOVERCRAFT HANDICAP - (RACE NO 15)

Trainer Suraj Prasad Shaw and Jockey M S Deora were called and questioned regarding the running and riding of "**EMPIRE OF DREAMS**".

The trainer informed his instructions were to sit 2nd/ 3rd since he is carrying top weight and do his best in the straight he said Jockey informed him soon after the start his horse threw his head up and got interfered by the horse on his outside when asked whether he was satisfied with Jockey M S Deora's ride he said he could have been more vigorous he opined with the Chief Stipendiary Steward that he did not use his whip in the straight and not vigorous in his riding effort.

Jockey M S Deora was asked to explain he informed his instructions were to sit 2nd / 3rd and do his best in the straight. The video recording of the race was shown when asked where his effort was near 600 mts and also in the straight.

Having considered the Submissions by the Trainer and also the past performance of Horse "EMPIRE OF DREAMS" the explanation tendered by Trainer was accepted and was asked to be more judicious in his future running of his Charges.

After hearing Jockey M S Deora's submission tendered by him the explanation was noted. However, considering all facts and findings Jockey M S Deora was fined **Rs 10,000/ for injudicious riding** on his mount "**EMPIRE OF DREAMS**".

He was asked to be more careful in his riding engagements. He was also informed of his Right to Appeal.

## 3<sup>rd</sup> Race: 16. The Giant's Causeway Handicap - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).

Permission was granted to Trainer Ramanathan .R to deputise on behalf of Trainer James Mckeown for IMPIANA (Soufyane J Moulin) at both trainer's risk and responsibilities.

QUEEN ANULA (K V Baskar) ran detached. Trainer Ajith Kumar V was called and questioned regarding the poor perfomance of QUEEN ANULA (K V Baskar). The Trainer's explanation was the fast pace of the race which he felt did not suit her style of running. The Explanation was noted . Trainer Ajith Kumar V was asked to be more careful running of his charge.

The Chief Veterinary Officer was asked to examine IMPIANA (Soufyane J Moulin) and LAVISH GIRL (Koshi Kumar).

The Chief Veterinary Officer reported after the race that no abnormalities were found on IMPIANA (Soufyane J Moulin). He reported, LAVISH GIRL (Koshi Kumar) was found to have a bit sore on left commissure of the mouth.

Routine Sample was taken for analysis from the winner SCHNELL (Yash Narredu)

# 4th Race: 17. The Astonish Trophy - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey P.Sai Kumar, the rider of RUBERT was fined Rs 1000/- for excessive use of whip.(1st Offence).

Jockey Ram Nandan Manjhi, the rider of ABILITARE was fined Rs1000/- for excessive use of whip (1st Offence).

The Club's Veterinary Officer reported after the race that no abnormalities were found on WISAKA (Sah Farid Ansari).

Routine Sample was taken for analysis from the winner RUBERT (P.Sai Kumar).

# 5<sup>th</sup> Race: 18. The Elusive Pimpernel Trophy - (About) 1400 metres. Horses rated 60 to 85 (5 Runners).

Permission was granted to Trainer Ramanathan .R to deputise on behalf of Trainer James Mckeown for ANDORRA (Soufyane J Moulin)at both trainer's risk and responsibilities.

During routine Veterinary examination on 12/09/2024 at 10.16 am ,RULING STAR was observed to have multiple injuries on his left hind and was permitted to be withdrawn on veterinary grounds .Trainer Deepesh Narredu was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

During routine Veterinary Examination on 13/09024, at 10.01 am KNOTTY WONDER (Sah Farid Ansari) had sustained injury and swelling on the Right fore Fetlock and was permitted to be withdrawn on veterinary grounds. Trainer Ramanathan R was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

Routine Sample was taken for analysis from the winner TURF MELODY (A S .Peter) .

## 6<sup>th</sup> Race: 19. The Southern Regent Handicap - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

During routine Veterinary examination on 13/09/2024 at 3.46 pm, GLORIOUS SUNSHINE (Shankar Lal H) was observed to be trotting lame on left hind and was permitted to be withdrawn on veterinary grounds. Trainer Fazal-Ul-Rehman was asked to get his charge certified by the Club's Veterinary Officer before accepting next with.

The Club's Veterinary Officer was asked to examine DESERT STAR (Ram Nandan Manjhi) after the race who reported that no abnormalities were found.

Routine Sample was taken for analysis from the winner PLUTO (Yash Narredu).
