Permission was granted to Trainer K. S. Mandanna to deputise and saddle on behalf of Trainer B.Suresh for WINDSOR WALK (Soufyane J Moulin) at both trainers risk and responsibilities.

Permission was granted to Trainer N. Rupa to declare Jockey Hindu Singh to ride EMPRESS ROYAL in place of Jockey Mukesh Kumar (Hyd) as he was declared to ride in Hyderabad.

Permission was granted to Trainer N. Rupa to declare Jockey C.A.Brisson to ride ROYAL FALCON in place of Jockey P.Sai Kumar as he was declared to ride in Hyderabad.

Permission was granted to Trainer Ajith Kumar V to declare A S .Peter, to ride GRANDIOSE in place of Jockey Kuldeep Singh as he was declared to ride in Hyderabad

Apprentice Jockey Jitendra Singh, the rider of ABNEGATOR was fined Rs 2000/- for not preserving his mount during final stages of the race.

The Club's Veterinary Officer was asked to examine SILK STUFF (M.S.Deora) KRISHVI (L.Alex Rozario) and ROYAL MARQUESS (C A Brisson) and HAPPINESS (Inayat) who reported after the race that no abnormalities were found in SILK STUFF (M.S.Deora), KRISHVI (L.Alex Rozario) and HAPPINESS (Inayat). And ROYAL MARQUESS (C A Brisson) was suffering from sore back. Trainer R.Foley was asked to get his charge certified fit by the Club's Veterinary Officer before accepting next with.

**4<sup>th</sup> Race: 103. The Buckpasser Handicap - Div. I - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).**

Permission was granted to Trainer Ajith Kumar V to declare Jockey L.Alex Rozario, to ride ALEXANDER in place of Jockey P.Sai kumar as he was declared to ride in Hyderabad.

Permission was granted to Trainer K. S. Mandanna to deputise and saddle on behalf of Trainer B.Suresh for KINGS WALK (Ram Nandan Manjhi) at both trainers risk and responsibilities.

ALEXANDER (L.Alex Rozario) came onto TYCOONIST (Hindu Singh) travelling on his inside near the 300 metres due to which Jockey Hindu Singh, had to stop riding momentarily.

Jockey Yash Narredu, the rider of HAWK OF THE WIND reported that the gelding was hanging in, in the final stages of the race.

The Club's Veterinary Officer reported after the race that no abnormalities were found in TYCOONIST (Hindu Singh).

Permission was granted to Trainer Fahad Khan to declare Jockey C A Brisson, to ride KING'S BATTALION in place of Jockey Mukesh Kumar as he was declared to ride in Hyderabad. .

Permission was granted to Trainer J.Sebastian to declare Jockey R N Darshan, to ride VISHWAS in place of Jockey P.Sai kumar as he was declared to ride in Hyderabad.

The Club's Veterinary Officer reported after the race that PLUTO (Yash Narredu) sustained superficial injury on upper muzzle.

Trainer Suraj Prasad Shaw. was questioned regarding the improved performance of his charge GROOVIN (M.S.Deora) winner of this race. Who finished unplaced in the previous races as compared to the present race. Trainer informed the gelding had severe sinus problem which was treated by Equine Hospital, the horse was coming back to hand and was running light weight today that also contributed to his victory. Explanation was noted, however the Trainer was cautioned to ensure his charges race more consistently in future.

**ADDITIONAL REPORT**

**ENQUIRY INTO THE RUNNING AND RIDING OF Ch f 4 year old "MAHADEVI" IN RACE NO 94 THE KINGSTON HANDICAP RUN ON SATURDAY 7-12-24 RIDDEN BY APP JOCKEY RAM NANDAN MANJHI ,TRAINED BY FAHAD KHAN**

In connection with the captioned subject, the Stewards of the Club at meeting held on Monday, December 16th 2024 after the last race having heard the submissions made by App Jockey Ram Nandan Manjhi , Trainer Fahad Khan who also lodged a written complaint against App Jockey Ram Nandan Manjhi also the Chief Stipendiary Steward having viewed the video recording of the race in question and previous runs of the Ch filly "MAHADEVI" and having

deliberated the matter at length, the Stewards were not satisfied with the explanation tendered by App Jockey Ram Nandan Manjhi

In that, App Jockey Ram Nandan Manjhi said that due to interference received soon after the start he could not position his mount "MAHADEVI" as per the instructions of his trainer where to be in 3rd 4th position and do his best. When shown the replay that he had gagged the filly he informed she through her head up when the start was effected and was riding this filly for the first time when shown the replay of various angles where was his effort coming into the straight . App Ram Nandan Manjhi didn't have a plausible answer except attributing the interference soon after the start. Where he said because the interference at the start his filly lost all her chances. When shown by the Chief Stipendiary Steward that he gagged her and there was no interference from either on his inside/outside and his riding in the straight.

The Stewards after submissions made by App Ram Nandan Manjhi and Trainer Fahad Khan that App Jockey Ram Nandan Manjhi gagged the filly soon after the start not let her go and preserve with his mount, thereby placing the filly at a disadvantage in the race thus, impacting the final outcome of the race.

The Stewards of the Club after hearing submissions by the Jockey and Trainer in conjunction with the Chief Stipendiary Steward keeping in mind "MAHADEVI " in her career as run 7 times till date still being maiden has a habit of throwing her head up also App Jockey Ram Nandan Manjhi riding for the first time the filly , she running under the charge of Trainer Fahad Khan for the first time Madras Racing Season keeping in mind all the above took a lenient view and decided to suspend App Jockey Ram Nandan Manjhi's licence for **4 race days (December 25, 31st, January 1st and 13th )** for "**UNSATISFACTORY RIDING**" on his mount "MAHADEVI" also severely reprimanded to make more determined efforts on his mounts failing which he will be liable for severe disciplinary action as deemed fit.
