MADRAS RACE CLUB DECLARATION BY APPLICANT

- (A) Strike out which ever is not Applicable
 - 1. I am a person resident of India, within the meaning of the Foreign Exchange Managemen Act 1999("the Act")
 - 2. I am a person not residing in India within the meaning of the Act and, therefore, whateve money I acquire in India, out of the activity of owning and racing horses in India shall be received by me only in India and in Indian rupees from the Club and I shall not remit such money outside India without the prior written permission of the Reserve Bank of India.
- (B) 1. I note that if this form is incomplete, it will be returned to me and may cause an inording delay. As such, I am advised to see that all the required information is clearly stated. If at a later date, the Stewards find that any of the above particulars furnished by me are incorrect, they will be at liberty to take any action againt me that they deem necessary under the Rules of Racing and to cancel the ownership of the horse/s forthwith.
 - 2. I confirm that I am bound by the Rules of Racing, Notifications, bye-Laws and all Rules Madras Race Club., prescribed from time to time, relating to the payment of the Maintenance Cost and other dues to Trainers and dues of the Club and confirm to be bou by the decisions of the Stewards of the aforesaid club.
 - 3. If my Husband / Spouse (as the case may be) is approved as an owner, I agree that in the event of the Stewards taking action him/her, it would be open for the Stewards to inq into my ownership and, at their discretion, to either revoke my approval or prohibit transfer of horses from such person to me. I shall also be responsible to clear the due my spouse.
 - 4. I am fully aware as to the cost of maintaing and racing a horse and the abovementioned particulars as stated by me are correct in every respect and no other persons have any Interest. financial or otherwise, in my share in the abovementioned horse/s.
 - 5. I hereby consent and undertake to be bound by the Articles of Association, Rules of Rac notification, bye-laws, other Rules and Regulations etc, of the club which are in force fi time to time, including without limitation, the provisons relating to the exclusive jurisdict Chennai Courts only.

- (C) I hereby by Agree to deposit an amount of **Rs.1,00,000/-** I also agree to the condition of the Club requiring to retain the said amount as deposit until Cessation of my Ownership and Subject to Clearance of all my dues to the club.
