I further undertake that the issuance of this license is liable to suspension and/or cancellation in the event of there being a breach on my part of the Rules and Notifications applicable to me.
4. I accept that as a licensed professional of the Club I have an obligation towards ensuring that Racing is properly conducted and administered and I shall not take any action or step which will have the effect of in any way disrupting or adversely affecting the Racing.
5. I hereby consent and undertake to be bound by the Articles of Association, Rules of Racing, and Notification, By-laws, other Rules and Regulation etc., of the Club which are in force from time to time.
6. I agree to pay the license Fee of Rs.250/- (plus applicable GST) or such other Fee as may be determined by the Stewards and accept that the said license fee shall not be refundable in any circumstances should racing be disrupted or my license be suspended or cancelled for any reason whatsoever.
7. I hereby authorize M.R.C., to debit from my Racing Account with the Club towards License Fee, Fines and Applicable Taxes, etc., or any other amount payable by me to the Club.
